Our GP's also provide the link to further health services and work closely with other healthcare colleagues. We may arrange hospital admissions and referrals to other services and specialists. We collect and record information from other healthcare professionals involved in the treatment of our patients.

Our GP's are involved in the education and training of doctors, practice staff and other healthcare professionals.

- iv. Hepatitis B
- v. MMR
- vi. Meningococcal Booster vaccination
- vii. Meningococcal ACWY
- viii. Meningococcal B
- ix. Alcohol Consumption Screening
- x. Learning Disability Health Checks
- xi. Minor Surgery Joint injections
- xii. Near Patient Testing
- xiii. Childhood Seasonal Influenza vaccination
- xiv. Seasonal Influenza and Pneumococcal Polysaccharide Vaccination
- xv. NHS Health Checks
- xvi. Shingles Vaccination (routine and catch up)

## **Other Services**
